Qualifying Customers

This program is applicable to the commercial / industrial and agricultural customers of East Central Energy.

Rebate Program Guidelines

East Central Energy offers cash rebates to qualifying customers who purchase and install VFDs.

Specific Rules and Qualifications

1. Rebates will apply only for new variable frequency drives.
2. Rebates apply to variable frequency drives in systems that:
 - Be tied to an automated control system
 - The VFD True Power Factor of .90 or greater
3. Approved applications of VFDs
 - HVAC fans, pumps, cooling towers, process equipment and industrial fans
4. Non-approved applications of VFDs:
 - Chillers, refrigeration compressors, irrigators and air compressors. These applications may be submitted for evaluation through the Custom Energy Rebate program. The VFD will be evaluated in conjunction with the equipment operating efficiency and loading. Additional applications not approved for VFD rebates include soft-start, power-factor correction, or related equipment.
5. Rebate is based on the rated VFD controlled horsepower or horsepower of motor, whichever is lower.
6. Rebates are not available on replacement VFDs.
7. Rebates are available for VFDs from 1 hp up to 200 hp. For VFDs greater than 200 hp must be evaluated with the Custom Energy Rebate program. The Custom Energy Rebate requires review and approval by East Central Energy and Great River Energy.
